The communications have to be confidential (secret) and they have to be for the purpose of seeking or receiving legal advice. In other words, the communications have to be between an attorney and a client or prospective client. I am not the attorney for the folks on the call, individually or collectively. Now if Wit Davis joins the call and we ask all non-board members to leave the call, and we ask for his legal advice, those communications would enjoy privileged status as long as none of us discloses what was discussed (you waive the privilege if you break confidentiality.)
