

## Jonathan Goldstein Biographical Summary

### ENTREPRENEURIAL:

A 1993 graduate of the University of Pennsylvania and a 2005 graduate of the University of Pennsylvania Law School, Jonathan S. Goldstein is an attorney, serial entrepreneur and private equity investor with a nearly 30 year track record of success.

Early in his career, Mr. Goldstein was one of the first employees of a company that would eventually go public as Interliant. He was also the founder and President of Urban Technology Group, Inc., a Philadelphia-based technology services company. According to the Philadelphia Business Journal, Urban Technology Group, Inc. was the fastest growing services company in Philadelphia from 2000-2002.

In 2002, Mr. Goldstein won the Philadelphia Business Journal's 40 Under 40 award as one of the most influential Philadelphians under the age of 40.

From 2002 to 2004, Mr. Goldstein served as an Adjunct Professor in Temple University's Fox School of Business teaching entrepreneurship and computer science to both undergraduates and M.B.A. candidates.

From 2006-2013, Mr. Goldstein was part of the management team of Pangea3 ([www.pangea3.com](http://www.pangea3.com)), the most successful company in the legal process outsourcing field with over 1000 India-based attorneys performing legal work for some of the largest law firms and companies in the world. The company was sold to Thompson Reuters in November, 2010.

Since 2012, Mr. Goldstein has been an active private equity investor as well as a New Jersey, Pennsylvania and DC admitted attorney engaged in the practice of law with a focus on business advisory, election law and firearms law ([www.goldsteinlp.com](http://www.goldsteinlp.com)). Some representative private equity transactions include:

- August, 2012: Purchased the assets of Schulmerich Carillons, Inc. of Sellersville, PA (now Schulmerich Bells of Hatfield, PA - [www.schulmerichbells.com](http://www.schulmerichbells.com)) - the world's leading manufacturer of musical handbells and electronic carillons. In March 2014, we sold the company's carillon business to its largest competitor, the I.T. Verdin Company of Cincinnati, OH. In November 2014, we sold the company's long time 9+ acre headquarters to WB Homes, a suburban developer who built 54 townhomes on the site in 2015, and relocated Schulmerich Bells to Hatfield, PA.
- October, 2015: Purchased the assets of Charleston, SC based marine heater company, The Boat Safe, Inc. ([www.theboatsafe.com](http://www.theboatsafe.com)) and relocated the company to Hatfield, PA.
- July, 2019: Purchased the assets of Xensor Corporation, a leading manufacturer of industrial sensors. The newly former Xensor, LLC ([www.xensor.com](http://www.xensor.com)) was relocated to Hatfield, PA in November, 2019.
- July, 2021: Purchased the assets of the former Empire Ventilation, Inc. of Florida, NY.
- November, 2021: Purchased the assets of the former Cook Technologies, Inc. of Green Lane, PA, including Cook's ~100,000 sq. ft. manufacturing facility and relocated Empire Ventilation, LLC into the Cook facility in Green Lane, PA.
- March, 2024: Sold the assets of Xensor, LLC to SenTech, Inc. - <https://www.sentechsensors.com/news/sentech-strengthens-sensor-portfolio-with-acquisition-of->

Mr. Goldstein has been married for more than 20 years and has three children. He and his family split their time between suburban Philadelphia and his family's historic home in Charleston, SC.

FIREARMS LAW:

Jonathan Goldstein brings nearly 25 years of experience as an entrepreneur and business owner to his law practice. Mr. Goldstein's practice focuses on firearms law and election law as well as entrepreneurial business advising.

Mr. Goldstein is an NRA certified pistol instructor and is a volunteer attorney for several firearms organizations including the National Rifle Association. He actively lectures on firearms law and firearms safety across Pennsylvania and is a frequent presenter for continuing legal education providers such as CAPE and the Pennsylvania Bar Institute. In May 2011, Mr. Goldstein was awarded the Defender of Justice Award by the National Rifle Association's Institute of Legislative Action for his "tireless service to the Constitution and with particular emphasis on the protection and furtherance of the Second Amendment." As of September, 2018, Mr. Goldstein sat for several years as a non-director member of the National Rifle Association board's Legal Affairs Committee and was also a member of the NRA's 2016 Nominating Committee.

Mr. Goldstein is also very active in Pennsylvania politics. He has twice been a candidate for the Pennsylvania General Assembly. Mr. Goldstein has litigated signature challenges in the Commonwealth Court of Pennsylvania and has briefed and won an election law appeal before the Supreme Court of Pennsylvania. He regularly represents state and national political parties as well as state and local candidates across the Commonwealth.

A brief prepared by Mr. Goldstein's firm was cited favorably by Justice Alito in his Bruen concurrence.

Mr. Goldstein received his undergraduate degree from the University of Pennsylvania in 1993. He returned to the University of Pennsylvania for law school, earning his J.D. in 2005. Mr. Goldstein is admitted to practice law in state and federal courts in Pennsylvania and New Jersey as well as several Circuit courts and the United States Supreme Court where his firm argued a case in the 2023-2024 term.
