**Resolution to the Members of the National Rifle Association  
Annual Meeting of Members  
Atlanta, Georgia  
April 26, 2025**

**Whereas**, the by-laws of the National Rifle Association stipulate the Executive Vice President, and the members of the Nominating Committee, are elected by a majority vote of the Board of Directors, and,

**Whereas**, evidence presented in the New York Attorney General versus the National Rifle Association civil trial demonstrated former Executive Vice President Wayne LaPierre colluded with some long time directors to manipulate the election of the members of the Nominating Committee through the use of "cheat sheets" for the purpose of populating that committee with supporters of Wayne LaPierre, and,

**Whereas**, trial evidence further demonstrated Wayne LaPierre collude with several long time directors to limit, to the degree possible, the selection of candidates for the annual election of directors to only those who supported him, and,

**Whereas**, trial evidence further demonstrated several long term directors who were vocal supporters of Wayne LaPierre engaged in retaliation against other directors who called for audits and investigations of the allegations of misuse of NRA funds by Wayne LaPierre; including removing those directors from their committee assignments; making derogatory statements about them; and refusing to substantively engage with them in the conduct of NRA business, all for the purpose of ostracizing and silencing them, and,

**Whereas**, over time this interference by Wayne LaPierre in the nominating and election processes was a significant contributing factor in the majority of the Board of Directors failing to properly address the now proven allegations of misuse of NRA funds for personal purposes by Wayne LaPierre and some of his associates, and,

**Whereas**, the failure of the Board of Directors to promptly and effectively act upon these allegations of wrongdoing by Wayne LaPierre, and some of his associates, put the NRA in legal jeopardy resulting in the New York Attorney General filing the civil lawsuit that has ultimately cost the NRA well over \$100 million in legal fees and other expenses, and,

**Whereas**, the now proven allegations of wrong doing by Wayne LaPierre, and some of his associates, has resulted in the NRA suffering a disastrous decline in membership and revenues, resulting in the severe decrease in NRA staff and the programs they provide to NRA members, and,

**Whereas**, The collusion between Wayne LaPierre and some long time directors has resulted in significant damage to the NRA's reputation and standing with members, former members, and the public as demonstrated by the loss of an additional 325,000 non-life members since January 2024.

**Therefore be it resolved**, that we, the Members of the National Rifle Association here present, condemn in the strongest terms the Executive Vice President acting in collusion with some long term directors who manipulated the nomination and election processes to restrict, to the degree possible, nominated candidates for election or re-election who were supporters of Wayne LaPierre, and,

**Be it further resolved**, that from here forward we demand the annual election of directors be free of collusion between the Executive Vice President and any Board member insure future nominations of candidates for the annual election of directors are free from any involvement or interference by the Executive Vice President, regardless of how insignificant it may appear; and that, to the degree possible, the number of candidates nominated for the election be at least 180% of the anticipated positions to be elected each year.
