Leadership & Advocacy:

 CSSA has now also retained the legal counsel of Mountain States Legal Foundation in preparation for a lawsuit to overturn Colorado's new permit-to-purchase common firearms regime.
- CSSA, its members, and Huey's team played an important role in the defeat of Colorado's attempted "assault weapon" bans in 2023 and 2024.
- Under Huey's leadership, CSSA's membership has increased by more than 200%—more than tripling in under two years.

- As Executive Director, Huey oversees the day-to-day execution of strategy, communications, legislative affairs, legal actions, shooting competitions, membership, and development for CSSA.
- He also serves on the NRA Membership Committee and connects CSSA's growing base of engaged gun owners to national NRA initiatives.

 Huey is an active participant in public dialogue on firearms policy, making frequent media appearances to advocate for pro-Second Amendment positions and regularly communicating with CSSA members and the general public through social media and grassroots alerts.
